

AMENDMENT NO. 4
To
Agreement for Inmate Health Care Services between

Canyon County, Idaho and VitalCore Health Strategies, LLC

The Agreement for inmate health care services, by and between Canyon County ("County"), Idaho, a political subdivision of the state of Idaho, and VitalCore Health Strategies, LLC, ("Contractor") is hereby amended, as set for below.

Whereas, on July 25, 2019, a Service Agreement (the "Agreement") was entered into between County and Contractor (collectively "Parties") to provide Health Care Services to the inmates at the Canyon County Adult Detention Facility and the Canyon County Juvenile Detention Facility, and said Agreement, by its terms, provides for amendment upon the written agreement of all Parties; and

Whereas, the Parties previously entered into Amendment No. 1, dated September 3, 2020, Amendment No. 2, dated June 10, 2021; and Amendment No. 3, dated August 9, 2022; and

Whereas, the Parties desire to further amend and extend the Agreement;

Now Therefore, the Parties do hereby agree to amend the Agreement as follows:

1. Contract Renewal. The Parties agree to renew the Agreement for one (1) year, effective October 1, 2023, ending September 30, 2024 for said extension term.
2. Staffing Plan. The current staffing plan per Amendment No. 3, shall remain in effect for Amendment No. 4.
3. Payment and Increase in Contract Price. The current annual totals for each correctional facility shall be increased by ten percent (10%) as set forth in Exhibit A. The increased amounts are \$218,149.50 for the Adult Detention Center and \$14,711.78 for the Juvenile Detention Center.

Amendment No. 4 shall result in the following total annual cost of:

Adult Detention Facility:	\$2,399,644.46
Juvenile Detention Facility:	\$161,829.54

4. The balance of the original Agreement remains in full force and effect.

The Parties have caused this Amendment No. 4 to be executed as dated below by their representative each of whom is duly authorized to execute the same.

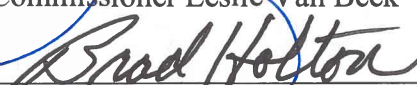
