Dear Canyon County Commissioners,

September 27, 2023

I am writing to formally request your approval of a list of polling locations for the November 7<sup>th</sup>, 2023 consolidated election. After careful consideration, we have identified several locations that we believe will serve our community to the best of our abilities.

November's election includes school district trustees, city council seats, mayoral races, fire district commissioners, Middleton liquor by the drink initiative, Middleton school supplemental levy, Nampa school district supplemental levy and city of Caldwell bon.

We believe each of these locations listed (Appendix A), will not only provide ample accessibility for voters, but also be able to accommodate the relative size of each community.

A temporary modification has been sent and is in process of being approved by the Secretary of State for precincts 0409 and 1310 for the November election. (Appendix B) This modification was made due to the low number of eligible voters within the precincts. Precinct 0409 has 19 eligible voters and 1310 has 88 eligible voters. Idaho State Code §34-308 allows for precincts which contain no more than 140 registered electors, to be designated as mail ballot precincts.

Registered voters within the approved mail ballot precincts, will be mailed a letter notifying each voter of the temporary modification after locations have been approved by the Board of Canyon County Commissioners. Mail ballots will then be sent out no sooner than twenty-four days prior to election day and no later than the fourteenth day prior to election day as stated in Idaho State Code §34-308(3).

As such, we ask that you review and approve these polling locations for the upcoming election. We thank you for your consideration and look forward to working with you to ensure that every citizen in our county is able to exercise their right to vote.
