Dear Canyon County Commissioners:

Gem County Board of County Commissioners has appointed Bryan Elliott to fill the remainder of its county's five-year term on the Southwest District Health Board of Health. Although Mr. Elliott previously held this position as a Gem County Commissioner, our legal counsel advised that SWDH reconfirm his appointment since there is no clear law on this specific situation when a board member's status changes from elected official to county designated Board of Health representative. The term will expire on June 30, 2027. The letter of appointment from the Gem County Board of County Commissioners is attached for your reference.

Ideally, appointees to the Board of Health should be chosen with regard to their knowledge and interest in public health and in promoting the health of the citizens of the state and public health district (IC 39-411.) Here is a link to the statute (IC 39-411) that outlines the appointment process. <u>https://legislature.idaho.gov/statutesrules/idstat/Title39/T39CH4/SECT39-411/</u>. Per the statute, all appointments need to be confirmed by a majority vote of all county commissioners of all the counties located within the public health district.
