By signing and dating below, this letter serves as the engagement Kirtlan Naylor of the law firm of Naylor & Hales, P.C. to conduct a fact-finding investigation on behalf of Canyon County ("the County"). The investigation will be subject to the Attorney Work Product Privilege in that the Civil Chief Deputy Carlton Ericson, on behalf of the Canyon County Prosecuting Attorney and as attorney for the Canyon County Board of County Commissioners, will be the direct contact for me

Any report provided by this firm, together with supporting documentation or interviews, will be kept confidential by this firm, except as directed or authorized by Mr. Ericson or his designee, to the extent such direction is consistent with applicable law, rules, or court order.

Billing for services and reimbursement as described above will be submitted via email to Mr. Ericson on a monthly basis, generally by the 5th day of each month. Payment in full is due within thirty (30) days of receipt of invoice.
