WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-828 grants the Board authority "to do and perform all other acts . . . which may be necessary to the full discharge of the duties of the chief executive authority of the county government"; and

WHEREAS, Idaho Code § 31-817 empowers the Board to fill by appointment vacancies that may occur in county offices; and

WHEREAS, On January 24, 2024, the written resignation of duly elected Canyon County Clerk Chris Yamamoto, effective February 2, 2024, was delivered to accepted by this Board, pursuant to Idaho Code § 59-902; and

WHEREAS, the Canyon County Republican Central Committee, pursuant to that body's bylaws as well as procedures established by Idaho Code § 59-906, convened on January 31, 2024, accept or review applicants to succeed Clerk Yamamoto in office for that Committee's nomination; and

WHEREAS, the Canyon County Republican Central Committee has fulfilled its process to present three names for consideration to the Board of County Commissioners: Rick Hogaboam, Jo Dee Arnold, and Steve Almer.

NOW THEREFORE, based on the recommendations by the Central Committee's thoughtful and well-reasoned endorsements, and this Board's independent inquiry, and good cause thereby appearing,

THE BOARD HEREBY RESOLVES, pursuant to Idaho Code §§ 59-906, 59-913, 59-916 and related law that Rick Hogaboam be appointed to serve as the Canyon County Clerk effective February 3, 2024, and that the powers, duties, and obligations attendant to such Office bestow upon him consequent to his sworn oath of office.
