RE: Purchase of Motorola Flex Services (GIS Migration to ArcGIS Pro)

E911 Board Chair,

The Canyon County Sheriff's Office (CCSO) has been using ESRI's ArcGIS Desktop software to support the GIS and mapping needs of Canyon County emergency communicators and responders for almost 20 years. ESRI is going to be ending support on older versions of the software March 1<sup>st</sup>, 2024 with end of life for all Desktop software scheduled for March 1<sup>st</sup>, 2026.

ESRI has been promoting the migration from Desktop to their 64-bit solution, "ArcGIS Pro" for several years now. We have been utilizing ArcGIS Pro since 2018 in our production editing environments, but could not put it in place for our Spillman GeoValidation workflows due to Spillman not being able to support it. Beginning with the 2023.3 Spillman patch, Spillman is now able to support ArcGIS Pro.


Attached is a quote and statement of work for Motorola's Flex GIS team to complete the migration to ArcGIS Pro for a total cost of \$9,681.69.

The Motorola Flex GIS Team will:

- Ensure that all GIS, Spillman, Windows, and Linux Operating Systems are at or above the appropriate patch level.
- Rebuild all of the ArcGIS Desktop tools in Spillman's ArcGIS Pro tools.
- Load final ArcGIS Pro tools on Flex GIS Server
- Perform system testing and training for GIS Personnel

This expenditure of E911 funds would be a direct investment into Canyon County's emergency services communications infrastructure that will ensure that our dispatchers responders will continue to maximize our Geographic Information Systems (GIS) investment.
