

RESOLUTION NO. 24-041

A RESOLUTION OF THE CANYON COUNTY BOARD OF COUNTY COMMISSIONERS INCREASING THE FEES CHARGED BY PICKLES BUTTE SANITARY LANDFILL FOR CERTAIN MATERIALS AND ESTABLISHING FEES FOR CERTAIN SERVICES

The following resolution and order was considered and adopted by the Canyon County, Idaho Board of Commissioners (“Board”) on this 2nd day of April, 2024.

Upon the motion of Commissioner Brooks and the second by Commissioner Van Boek, the Board resolves as follows:

WHEREAS, Idaho Code § 31-870(1) authorizes the Board to “...impose and collect fees for those services provided by the County which would otherwise be funded by ad valorem tax revenues”; and

WHEREAS, Idaho Code § 31-870(1) and 63-1311 require that the fees imposed and collected by the County must be reasonably related and not exceed the actual cost of the services being rendered; and

WHEREAS, the Board of County Commissioners provided proper legal notice of a hearing held on March 26, 2024, at 9:30 a.m. to take public testimony on and to consider a resolution proposing an increase to certain fees for Pickles Butte Sanitary Landfill; and

WHEREAS, pursuant to Idaho Code § 63-1311A, a public hearing was held March 26, 2024, and no one appeared to express opposition to the increases; and

WHEREAS, the Board of County Commissioners finds good cause to increase fees for the disposal of certain materials at the Pickles Butte Landfill, and to establish fees for certain services, as described in Attachment 1; and

WHEREAS, the Board of County Commissioners finds that the new fees and fee increases are necessary to cover the costs of the services provided, and that such fees and fee increases are reasonably related to, and do not exceed, the actual cost of the services being rendered.

NOW THEREFORE, THE BOARD HEREBY RESOLVES, that the new fees and increased fees, as described in Attachment 1, shall be effective October 1, 2024, at the Pickles Butte Sanitary Landfill. These fees are reflected in the Fee Schedule (Attachment 2).



IT IS FURTHER RESOLVED BY THE BOARD, that notice of said increase shall be conspicuously posted at the scale house of the Landfill for at least sixty (60) days before October

1, 2024, that a press-release be issued by the County regarding the increase at least thirty (30) days prior to October 1, 2024, and that the Landfill Director send a letter to the Owyhee County Board of Commissions and all customers with accounts, advising them of the increase at least sixty (60) days prior to October 1, 2024.

IT IS FURTHER RESOLVED BY THE BOARD, that this resolution shall be effective this 2nd day of April, 2024.
