WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-807 authorizes the Board to manage county property subject to restrictions including, but not limited to, those described in Idaho Code § 31-808; and

WHEREAS, Idaho Code § 31-829 authorizes any elective county officer to sell personal property which in their judgement and with the consent of the Board is of no further use to the County; and

WHEREAS, certain personal property listed in Exhibit "A" is no longer necessary for the county's use and is obsolete; and

WHEREAS, the personal property listed in Exhibit "A" is not suitable to sell to members of the general public so is of nominal value; and

WHEREAS, the Sheriff wishes to allow his deputies to purchase the personal property listed in Exhibit "A" in order to offset the cost to taxpayers of replacement personal property.

NOW THEREFORE, THE BOARD HEREBY FINDS, that the above-described personal property cannot be sold at public auction for greater than \$250.00 each, is of nominal value, and is surplus to replacement personal property to be purchased.

ACCORDINGLY, THE BOARD HEREBY RESOLVES, that the above-described property is now surplus property which will be taken out of service by the Canyon County Sheriff and privately disposed of.
