A RESOLUTION OF CANYON COUNTY, IDAHO, INCREASING AN ADMINISTRATIVE FEE CHARGED BY THE CANYON COUNTY ASSESSOR FOR VEHICLE TITLE SERVICES

The following Resolution was considered and adopted by the Canyon County Board of County Commissioners (hereafter "Board") on this 1 st day of October, 2024.
Upon the motion of Commissioner and the second by Commissioner, the Board resolves as follows:
WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the Board; and
WHEREAS, Idaho Code § 31-828 grants the Board authority "to do and perform all other acts which may be necessary to the full discharge of the duties of the chief executive authority of the county government"; and
WHEREAS, Idaho Code § 31-870(1) authorizes the Board to "impose and collect fees for those services provided by the county which would otherwise be funded by ad valorem tax revenues";
WHEREAS, Idaho Code §§ 49-202 and 31-870(4) allows the County, as a public entity to charge an administrative fee for the issuance of a motor vehicle title required by law; and
WHEREAS, Idaho Code §§ 31-870(1) and 63-1311 require that the fees imposed and collected by the County must be reasonably related to, and not exceed, the actual cost of the services being rendered; and
WHEREAS , on May 30, 2023, the Board approved Resolution No. 23-145, which established an administrative fee of \$6.00 to be charged by the Canyon County Assessor ("Assessor") for the handling of motor vehicle titles; and
WHEREAS, the Assessor has determined that the operation costs to run the Department of Motor Vehicles ("DMV") exceeds the funds received through the administrative fee; and
WHEREAS , the Assessor has deteremined that the administrative fee should be increased from \$6.00 to \$7.00 to support the associated costs to run the DMV; and
WHEREAS. Idaho Code § 63-1311A requires the Board to publish notice of and hold a public hearing prior to approving a fee increase that exceeds five percent (5%); and

WHEREAS, the Board caused to be published in the Idaho Press-Tribune on the 20th day of September, 2024 and the 27th day of September, 2024 a notice of a public hearing to be held on the 1st day of October, 2024 regarding the adoption of the proposed fee; and

WHEREAS, the Board held a public hearing on the 1st day of October, 2024, regarding the increase of the proposed fee.

NOW, THEREFORE, THE BOARD RESOLVES AND ORDERS that the DMV administrative fee for motor vehicle titles be increased to Seven Dollars (\$7.00).

IT IS FURTHER ORDERED that this Resolution shall be effective the 1st day of October, 2024.
