CANYON COUNTY JAIL FOOD SERVICE & COMMISSARY AGREEMENT FY 2025 RENEWAL NO. 1 & AMENDMENT

This Agreement to renew and amend the Canyon County Jail Food Service and Commissary Agreement for FY 2025 ("Renewal") is made between Canyon County, a political subdivision of the state of Idaho ("Client") and Summit Food Service, a New Mexico Limited Liability Company ("Company") and shall be effective on October 1, 2024.

WHEREAS, Client and Company ("Parties") entered into the Canyon County Jail Food Service and Commissary Agreement No. 23-170 ("Agreement") on December 7, 2023 that is effective until September 30, 2024;

WHEREAS, section 1.3 of the Agreement included the option for the Parties to renew the Agreement for four additional one-year periods, contingent upon the fulfillment of all agreement provisions related to donated foods;

WHEREAS, the donated food contingency has been met and both Parties desire to renew the Agreement subject to the amendments set forth below.

THEREFORE, in exchange for valuable consideration, the Parties mutually agree as follows:

I. RENEWAL

The Agreement shall be extended for an additional one-year period, commencing October 1, 2024 until September 30, 2025. This renewal is the first of four renewals, leaving three renewals available pursuant to section 1.3 of the Agreement. All other terms and conditions of the Agreement, including all attachments and exhibits, shall remain in full force and effect unless amended below.

II. AMENDMENTS

1. <u>Inmate Meal Pricing.</u> Pursuant to section 8.11 of the Agreement, the Parties agree to a five percent (5%) per meal cost increase to Clients. Accordingly, the table section 8.1 of the Agreement shall be replaced with the following:
