

RESOLUTION NO. 23-045

**RESOLUTION OF THE CANYON COUNTY BOARD OF COUNTY COMMISSIONERS
WAIVING CERTAIN LANDFILL FEES FOR CANYON COUNTY RESIDENTS FOR
ONE DAY ONLY ON SATURDAY, APRIL 22, 2023**

The following resolution was considered and adopted by the Canyon County, Idaho Board of Commissioners ("Board") on the 11th day of April, 2023.

Upon the motion of Commissioner Van Brock and the second by Commissioner Holtz the Board resolves as follows:

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-828 grants the Board authority "to do and perform all other acts . . . which may be necessary to the full discharge of the duties of the chief executive authority of the county government"; and

WHEREAS, the Board has the power pursuant to Idaho Code and the Canyon County Solid Waste Disposal Regulations (County Ordinance) to establish, change or modify fees at the Pickles Butte Landfill by resolution of the Board; and

WHEREAS, the Board desires to waive certain landfill fees for Canyon County residents for one day only, on Saturday, April 22, 2023, for the purposes of promoting countywide clean-up for the improvement of the community.

NOW THEREFORE, THE BOARD HEREBY RESOLVES that it is in the best interest of Canyon County to waive landfill fees for Canyon County residents only, for one (1) day only, on Saturday, April 22, 2023, for countywide clean-up, subject to the following conditions:

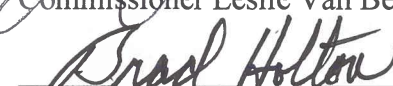
1. Residential clean-up waste up to one ton per household will be accepted without charge. Residential clean-up waste in excess of one ton per household will be accepted in accordance with the regular landfill fee schedule less a credit given for the first ton.
2. Cities may provide collection bins for purposes of participating in the countywide clean-up, provided residents are limited to one ton per household. Cities may deliver these collection bins on Monday, April 24, 2023, without charge provided the driver of the vehicle provides a letter of verification at the time of waste delivery, written on city letterhead and signed by the mayor or director of public works, stating that the waste was collected in accordance with this resolution.

3. Only one (1) refrigeration unit will be accepted free of charge per household. Additional refrigeration units will be accepted in accordance with the regular landfill fee schedule.
4. Up to four (4) passenger car/light truck tires will be accepted per household. Additional tires will be charged in accordance with the regular landfill fee schedule. Tires larger than passenger car/light truck will not be accepted.
5. All other waste, including waste being delivered by commercial haulers will be accepted in accordance with the regular landfill fee schedule. Commercial haulers that deliver waste from community collection events must provide a letter of verification at the time of waste delivery, written on city letterhead and signed by the mayor or director of public works, stating that the waste was collected in accordance with this resolution.
6. Wood waste and metal should be separated from other waste, as should tires and refrigeration units. Community collection sites must provide separate bins for these purposes. Acceptable wood waste includes: tree limbs, tree trunks and stumps, orchard trimmings, shrubs, lumber scrap, wood house siding, wood packing scrap and pallets, wood shingles without tar paper, particle board, wood fencing, painted wood scrap and leaves.

IT IS FURTHER RESOLVED BY THE BOARD, that this resolution shall be effective this 11th day of April, 2023.
