Upon the motion of Commissioner Van Beev and the second 1 Commissioner the Board resolves as follows:	by

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 34-301 grants the Board authority to establish a convenient number of election precincts therein; and

WHEREAS, Idaho Code § 34-301 authorizes the county clerk of each county to provide an accurate report and map of precincts within the county and the County Clerk having complied with his mandate and provided the same to the Board; and

WHEREAS, Idaho Code § 34-302 requires the Board to designate a suitable polling place for each election precinct, by the fifth Friday before any election; and

WHEREAS, the next Canyon County election will take place on May 16, 2023; and

**WHEREAS**, on March 29, 2023, the Secretary of State approved precincts 0209, 0810 and 1310 to be mail ballot precincts for the May 16, 2023 election, which approval is attached hereto as Exhibit "A."

WHEREAS, the Board has reviewed the materials provided by the County Clerk, attached hereto as Exhibit "B," and determined the designated precincts represent a convenient number of election precincts.

**NOW THEREFORE**, the Board herein resolves to designate the identified polling locations as suitable for each election precinct.
