After the Idaho Territory was created in 1863, <u>13 new counties were formed</u>, and after Idaho became a state in 1890, the process continued. In 1892, the Legislature authorized a local election to see whether those affected were in favor of dividing Ada County to create a new county in the west. The desire to be as self-governing as possible would lead prominent citizens in larger Idaho towns to lobby the Legislature to allow such a vote to create a new county, with their town as county seat. Probably no new county was born with as much excitement and celebration as was Canyon County in 1892.

- Timeliness of communication is key.
- County was not invited to be involved in the hotel discussions and the impacts to the Fair.
- Caldwell adopted an Event District on ground that the County has the right to use for Fair and other Public use Purposes.
- There are only two official land owners in this City Event District. City of Caldwell / Canyon County.

1) Barn Improvement

- Immediate Fix: Remove the dividers in the area and install overhead power. This will help open up the space for trailer and larger vehicle parking.
- Pave the entire area under the roof. For events involving animals or livestock, sod and shavings could be added to cover the asphalt. (The horse park in Nampa uses a similar approach with concrete and dirt covering.)
- Grass Area: Leave the grass area east of the catch pins as-is for use by 4H clubs. Expansion may be considered in the future when the structure is rebuilt. Small banquets and meetings could also be hosted in the area in the future.

2) Wash Station

- Remove the wash station currently located north of the catch pins and relocate it to the area near the rabbit barn.
- The rabbit barn isn't effectively used for rabbits due to extreme heat.
- This project would take about half a day to complete, and sever and water are already available near the rabbit barn (the wash station is circled in yellow and the rabbit barn in green below).

3) 22nd Avenue Vacation

 Convert 22nd Avenue into a one-way road to add parallel parking, including spots designated for veterans and ADA parking.

 Gate and cap the area as part of this improvement. DISCUSSION

4) Ride-Share Area•Designate the area where the Buckaroo

Breakfast is currently held as a **rideshare area** with a small shelter. This could serve as a pick-up and drop-off point for elderly attendees and those using Uber, Lyft, or other services.

5) Barn Relocation

- Relocate the portable barns currently behind the Charolais Barns.
 Movable goat barns purchased by the county could be relocated to the east of the county fair building.
- The red barns, built with City, rodeo, and fair funding, are currently used for storage. These could be demolished to create additional space for trailer parking. The portable barns are circled in yellow, while the red barns are in maroon below:

6) Gabiola Fields

•Convert part of Gabiola Fields to **road mix** for year-round parking. •Add shade trees to address heat concerns.

 This would reduce maintenance challenges, such as broken sprinklers and mowing while increasing parking capacity for the CEC.

Proposed Hotel at Stock Trail Rd and S 21st Avenue

- Board has received multiple emails expressing opposition around the hotel as it relates to the Canyon County Fair.
- Concerns with reduced County Fair revenues and potential property tax Increases to remediate the needs.
- Safety concerns for the Fair, exhibitors, 4-H youth, livestock and other events.
- Parking Plans for livestock shows and other events.
- On December 2nd, Caldwell City Council approved a Letter of Intent to build a hotel.
 - County interests were not considered in this decision.
 - Start date of construction presents an issue.
 - Developer committed to wait during our 11/7/24 meeting on ground breaking until after the 2025 Fair and Rodeo events.



Commissioners' Statement

Over 30 years ago, the Griffith family generously dedicated portions of what is now known as the Caldwell Events Center and Griffiths Park for the perpetual use for the County Fair. Thanks to this gift, this property has remained the home of the County Fair for generations.

The Canyon County Board of County Commissioners will vigorously defend the intent of the Griffiths family to maintain this site as the home of the County Fair against any restrictions of the County Fair's use or any attempts to convert the property to private commercial use.

Accordingly, the Board requested the Canyon County Prosecutors' Civil legal counsel to review Caldwell's proposed plans which may result in a violation of the Griffith's gift deed to the citizens of the County. Upon legal review, the County will pursue any legal options available to preserve the Griffith family's intent that the County Fair remain on this property.

Commissioner Closing Remarks

- Canyon County wants to honor the intent of the (3) Griffith gift and warranty deeds on the properties to the south east of the Center Expo building (County Fair Avenue to Linden). Legal is currently reviewing and is of the opinion that the County has jurisdiction on the use based on the Griffith family written intentions.
 - County Fair use, AG Expo and Public use purposes
- County Fair growth plan is being developed.
- Economic benefit that the Canyon County Fair brings to the city is large. We believe no other event brings in more attendance to the area than the Fair. We are concerned about the impacts to our 4-H and FFA programs in partnership with the University of Idaho County Extension.
- No Official Board letter has been sent to the City to show support or opposition of the hotel. The official response is...(discussion)
