WHEREAS, the outgoing Canyon County Prosecuting Attorney, Bryan F. Taylor, has under his jurisdiction or control personal property that has been assigned to his possession and official use as follows:

• Personalized Canyon County Prosecuting Attorney badge for Douglas W. Robertson; and

WHEREAS, Douglas W. Roberts has served the citizens and law enforcement partners of Canyon County as a deputy prosecuting attorney for more than twelve (12) years, and is currently the Chief Criminal Deputy, and the Board would like to recognize his years of service by presenting him with his personalized Canyon County Prosecutor badge in honor of his tenure in Canyon County;

NOW THEREFORE, THE BOARD HEREBY FINDS, that the above-described personal property is reasonably unlikely to sell at public auction for greater than \$250.00 each, is of nominal value, and/or is obsolete and cannot be used by any other County employee.

ACCORDINGLY, THE BOARD HEREBY RESOLVES, that Douglas W. Robertson be awarded his badge on his final day of employment with Canyon County on January 10, 2025.
