WHEREAS, Idaho Code § 34-302 requires the Board to designate a suitable polling place for each election precinct, by the fifth Friday before any election; and

WHEREAS, the next Canyon County election will take place on May 20, 2025; and

WHEREAS, the Board has reviewed the materials provided by the County Clerk, attached hereto and fully incorporated by reference as Exhibit "A," and determined the designated precincts represent a convenient number of election precincts and voting locations.

**NOW THEREFORE**, finding good cause and upon the recommendation of the County Clerk, the Board hereby designates the polling locations identified on Exhibit "A" as suitable for each election precinct for the May 20, 2025 election.
