




SUMMARY OF ORDINANCE NO. 25.000

 - a.** An Ordinance adopting Chapter 7, Article 9, Agricultural Protection Area Act of the Canyon County Code of Ordinances.
 - b.** Chapter 7, Article 9, Agricultural Protection Area Act is adopted to comply with a law passed during the 2024 legislative session under Title 67, Chapter 97, Agricultural Protection Area Act.
 - c.** Chapter 7, Article 9, Agricultural Protection Area Act includes Sections: 1 Purpose; 3 Definitions; 5 Creation and Designation of APA; 7 Review Process; 9 Expansion or Modification of APA; 11 Termination of an APA; 13 Enrollment Duration; 15 Fees; and 17 Prohibitions.
