Canyon County Commissioners:

On February 26, 2025, the Sheriff's Civil Office took over responsibility for the collection of 237 delinquent personal property tax payments to Canyon County. Our office recently completed this task and collected **\$83,964.37** on behalf of the Canyon County Treasurer.

The Sheriff's Office determined ten (10) of the delinquent accounts were uncollectible, resulting in \$1,039.86 of uncollected taxes and \$1,080.80 of uncollected Sheriff fees. A detailed list of the uncollectible accounts is attached to this letter.
