Upon the motion of Commissioner Van Box and the second by Commissioner the Board resolves as follows:

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-828 grants the Board authority "to do and perform all other acts... which may be necessary to the full discharge of the duties of the chief executive authority of the county government"; and

WHEREAS, Idaho Code § 31-807 authorizes the Board to manage county property subject to restrictions including, but not limited to, those described in Idaho Code § 31-808; and

WHEREAS, on July 1, 2023, the State of Idaho, Division of Finance began receiving reimbursement payments collected by each county from medically indigent individuals under Idaho Code § 31-3503, which funds were previously designated for the Catastrophic Healthcare Cost Program; and

WHEREAS, the Board receives a quarterly report showing collections received and there is one annual reimbursement payment to the state of Idaho; and

WHEREAS, the annual payment to the state of Idaho will be made in June each year to cover the previous twelve (12) months of reimbursement (payments from June 1 through May 31 of the following year); and

WHEREAS, the Board has determined in order to support the collection efforts from our staff, the County should retain 30% of such annual collection as an administrative fee.

NOW THEREFORE, THE BOARD HEREBY RESOLVES, that the County shall implement an administrative fee, which will be 30% of the reimbursement payments (collections) received. Said administrative fee shall be retained from the annual one-time payment to the State of Idaho, Division of Finance.
