WHEREAS, Idaho Code § 31-801 grants general powers and duties to the Board, subject to the restrictions of law; and

WHEREAS, Idaho Code § 31-807 authorizes the Board to manage county property subject to restrictions including, but not limited to, those described in Idaho Code § 31-808; and

WHEREAS, the Canyon County Sheriff's Office ("CCSO") has determined that it is no longer in need of certain HP hard drives and that the property is not suitable for donation to another agency for use, and that the drives must be destroyed to ensure no information will be recovered from the drives; and

WHEREAS, the Canyon County Sheriff's Office has determined such personal property has a nominal value, has taken it out of service, and it is now surplus property; and

**WHEREAS**, the Canyon County Sheriff's Office desires to destroy certain personal property as described in Exhibit 1 attached hereto and incorporated by reference; and

**WHEREAS**, the Canyon Prosecuting Attorney's Office has reviewed this resolution and rendered advice to the Board and CCSO.

**NOW THEREFORE,** the Board hereby resolves and concludes that the property as described in Exhibit 1 is surplus property with nominal value and is no longer of use to the Canyon County Sheriff's Office.

**IT IS HEREBY RESOLVED,** that the Canyon County Sheriff's Office is authorized to destroy and/or dispose of the certain personal property described in Exhibit 1. Such disposition shall be under the direction and supervision of the Canyon County Sheriff.
