**RESOLUTION OF THE CANYON COUNTY BOARD OF COUNTY COMMISSIONERS
ALLOWING TRANSFER OF FUNDS RECEIVED FROM THE ANNUAL IDAHO
CIGARETTE TAX REVENUE BY JUVENILE PROBATION TO THE JUVENILE
DETENTION CENTER IDAHO CODE § 31-1508**

The following resolution and order was considered and adopted by the Canyon County, Idaho Board of Commissioners ("Board") on this 30th day of October, 2025.

Upon the motion of Commissioner Brooks and the second by Commissioner Van Beek, the Board resolves as follows:

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-828 grants the Board authority "to do and perform all other acts . . . which may be necessary to the full discharge of the duties of the chief executive authority of the county government"; and

WHEREAS, Idaho Code § 31-807 authorizes the Board to manage county property subject to; and

WHEREAS, Juvenile Probation receives revenue from the annual Cigarette Tax, provided by that State of Idaho, to provide financial assistance to local juvenile justice functions. In accordance with the approved fiscal year 2025 budget, \$15,000 of this revenue shall be allocated to the Juvenile Detention Center; and

WHEREAS, Idaho Code § 31-1508 allows the Board discretion to transfer money from the Juvenile Probation fund to the Juvenile Detention Center fund; and

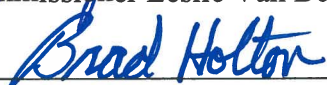
NOW THEREFORE, THE BOARD HEREBY RESOLVES, that pursuant to Idaho Code § 31-1508, the Board Authorizes the County Auditor to process a transfer of \$15,000 from the Juvenile Probation fund to the Juvenile Detention Center fund as described in Exhibit "A", and as follows:

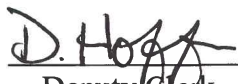
