RESOLUTION NO.25-229

A RESOLUTION OF THE CANYON COUNTY BOARD OF COUNTY COMMISSIONERS AUTHORIZING CANCELLATION OF TAXES ON PROPERTY OWNED BY CANYON COUNTY

The following resolution and order was considered and adopted by the Canyon County, Idaho Board of Commissioners ("Board") on this <u>loth</u> day of December 2025.

Upon the motion of Commissioner Lan Beek and the second by Commissioner Brooks, the Board resolves as follows:

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-828 grants the Board authority "to do and perform all other acts... which may be necessary to the full discharge of the duties of the chief executive authority of the county government"; and

WHEREAS, Title 39, Chapter 31 of the Idaho Code authorizes the creation of ambulance service districts as a political subdivision of the state of Idaho with legal taxing authority to provide a government function; and

WHEREAS, a county-wide ambulance service district known as the Canyon County Ambulance District operates in Canyon County and Board serves as the District governing board pursuant to Idaho Code § 31-3908(3); and

WHEREAS, Idaho Code § 31-3903 empowers the Board to make expenditures form the ambulance service fund maintained by the County Treasurer to purchase real property for use of the ambulance service; and

WHEREAS, Idaho Code § 63-602A provides that local government property is exempt from taxation; and

WHEREAS, Canyon County Parcel Nos. 02713000 0, and 02714000 0 were purchased by the Board for the use of District; and

WHEREAS, a Warranty Deed conveying the parcels to Canyon County Ambulance District was recorded on October 22, 2025, see Attachment 1; and

WHEREAS, the District has received notice of tax charges in the amount of Nine Hundred Sixty-One Dollars and Eighty-Four Cents (\$961.84) for Parcel No. 02714000 0 and Nine Hundred Fifty-Six Dollars and Two Cents (\$956.02) for Parcel No. 02713000 0; and

WHEREAS, Parcel Nos. 02714000 0 and 02713000 0 as real property owned by the Canyon County Ambulance District should be exempt from taxation.

NOW THEREFORE, THE BOARD HEREBY RESOLVES, that the taxes on the property for Parcel Nos. 02714000 0 and 02713000 0, located at 0 Ellis Avenue and 119 E. Elm Street in the amount described above are cancelled.

IT IS FUTHER RESOLVED BY THE BOARD, that this cancellation shall be shown as a credit on the official records of Canyon County and all necessary adjustments shall be made in the tax records of the various County officers and taxing districts.

IT IS FURTHER RESOLVED BY THE BOARD, that this resolution shall be effective this _______ day of December, 2025.
