

RESOLUTION NO. 25-233

**A RESOLUTION OF THE CANYON COUNTY BOARD OF COUNTY
COMMISSIONERS DESIGNATING PROPERTY AS
SURPLUS WITH NOMINAL VALUE**

The following resolution and order was considered and adopted by the Canyon County, Idaho, Board of Commissioners ("Board") on this 18th day of December, 2025.

Upon the motion of Commissioner Brooks and the second by Commissioner Van Boek, the Board resolves as follows:

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-807 authorizes the Board to manage county property subject to restrictions including, but not limited to, those described in Idaho Code § 31-808; and

WHEREAS, Canyon County is no longer in need of certain personal property that will now be taken out of service by the Canyon County Misdemeanor Probation Department and is now surplus property; and

WHEREAS, the Board has determined that the personal property, described below, is of limited value to the County and would individually not sell at public auction for a sum exceeding two hundred fifty dollars (\$250.00) each:

- Misdemeanor Probation Officer duty badge for Julie Cornell.

WHEREAS, Julie Cornell has served the citizens of Canyon County for more than 27 years and served the County and Courts of Canyon County as a Misdemeanor Probation Officer for more than 16 years, and the Board would like to recognize their years of service by presenting her with her Canyon County Misdemeanor Probation Officer duty badge in honor of their tenure in Canyon County.




