Upon the motion of Commissioner Brooks and the second by Commissioner Lon Book, the Board resolves as follows:

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-828 grants the Board authority "to do and perform all other acts . . . which may be necessary to the full discharge of the duties of the chief executive authority of the county government"; and

WHEREAS, Idaho Code § 31-1605 provides that the Board may adjust the budget to reflect unscheduled revenue, grants, or donations from federal, state or local governments or private sources, provided that there shall be no increase in anticipated property taxes; and

WHEREAS, during Fiscal Year 2025 ("FY25") the County will have enough additional revenues to cover the overages for Clerk – Recorder, Landfill, Court Facilities and Sheriff; and

WHEREAS, for FY25, the County will transfer expense savings from salaries and benefits 'A; to other expenses 'B' for Emergency Management; and

WHEREAS, for FY25, the County will transfer expense savings from other expenses 'B' to salaries and benefits 'A; for Commissioners and Clerk – County Assistance; and

WHEREAS, for FY25, the County will use fund balance; for Court Device and SAUSA; and

WHEREAS, the Board finds that adjustments to the FY25 budget are necessary to reflect unanticipated increase in operating expenses related to general operating expenses for the Emergency Management, Landfill, Court Facilities, and Court Device; and

WHEREAS, the Board finds that an adjustment to the FY25 budget is necessary to reflect unanticipated salary expenses for the Commissioners, Clerk – County Assistance, Sheriff, Clerk – Recorder, and SAUSA; and

WHEREAS, the Board complied with annual budget procedure with as nearly as practicable before considering such adjustment; and

WHEREAS, the County Clerk recommends the FY25 budget be adjusted as follows:
