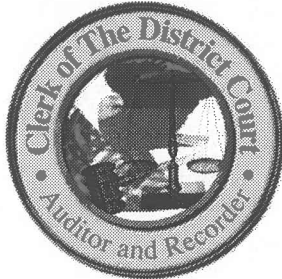

ORDINANCE NO. 25-020
AN ORDINANCE OF CANYON COUNTY, IDAHO, REPEALING
CHAPTER 09, ARTICLE 05, AREAS OF CITY IMPACT, CITY OF HOMEDALE
OF CANYON COUNTY CODE OF ORDINANCES

WHEREAS, the Board of County Commissioners following a public hearing procedure required in Idaho Code §67-6526(3) denied the City of Homedale’s request to confirm its current area of impact because the area of impact no longer meets the statutory criteria therein.

NOW THEREFORE IT IS ORDAINED, by the Canyon County Board of County Commissioners as follows:

Ordinance No. 10-012, the ordinance known and cited as *HOMEDALE AREA OF CITY IMPACT (PLANS AND ORDINANCES/MAP) ORDINANCE*, Chapter 09, Article 05 is hereby repealed in its entirety.




