AN ORDINANCE AMENDING SECTION 13 OF ARTICLE 02 OF CHAPTER 11 CANYON COUNTY CODE OF ORDINANCES; PROVIDING FOR:

- AMENDING FIRE DISTRICT DEVELOPMENT IMPACT FEE SCHEDULE OF MARSING RURAL FIRE DISTRICT; AND
- PROVIDING AN EFFECTIVE DATE AND PUBLICATION.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Canyon County, Idaho, that the Canyon County Code of Ordinances, BE AMENDED AS FOLLOWS:

Section 1: Amending Section 13 Article 02, Chapter 11 Canyon County Code of Ordinances to read as follows:

11-02-13: MARSING RURAL FIRE DISTRICT IMPACT FEE SCHEDULE:

The impact fee schedule costs per service unit for the Marsing Rural Fire District is as follows:

Residential (per dwelling unit)	\$1,238.00
Non-residential (per square foot)	\$0.62
<u>Residential (per Single Family per Housing Unit)</u>	<u>\$1,500.00</u>
<u>Residential (per Multi-Family per Housing Unit)</u>	<u>\$ 720.00</u>
<u>Non-Residential (per 1000 retail square feet)</u>	<u>\$ 1,485.00</u>
<u>Non-Residential (per 1000 office square feet)</u>	<u>\$ 1,080.00</u>
<u>Non-Residential (per 1000 industrial square feet)</u>	<u>\$ 510.00</u>
<u>Non-Residential (per 1000 Institutional square feet)</u>	<u>\$ 1,065.00</u>

Section 2: Date of Effect and Publication

3.1 This Ordinance, shall be in full force and effect on its passage, approval and publication within the 30th day following its passage and approval; and shall be published in full or by summary as provided in Idaho Code Section 31-715A within one month of its passage and approval all according to law.
