Order Form shall automatically renew at the stated rate plus 5% at the date of renewal for a subsequent twelve month term (each, a "Renewal Term") unless a new fully executed Order Form is in place prior to the expiration date or either party provides the other party with a written notice of its intent not to renew at least sixty (60) days prior to the end of the then-current Initial or Renewal Term.

4. License Additions; Overage Charges: In the event that Customer desires to add additional users during the initial term or any Renewal Term, such additional users may be added at the price per unit set forth in the table above. Any such request by Customer must be made in writing. Upon acknowledgement and acceptance by DNSFilter, DNSFilter shall then automatically invoice Customer for such additional users and Customer shall pay such invoice within 30 days of receipt. Any added users shall be made co-terminous with the then current term. For purposes of clarity, users may never be decreased during any initial or Renewal Term. Additionally, in the event that Customer's actual usage exceeds the number of users licensed under the terms of this Order, overage charges shall apply at the price per unit set forth in the table above and Customer will be responsible for remitting such overage fees; DNSFilter will remit an invoice for such overage charges and Customer shall pay such invoice within 30 days of receipt.
5. PO Requirements: If Customer's procurement process requires that a purchase order be provided to DNSFilter for it to be able to invoice, Customer must provide such purchase order to DNSFilter within five (5) business days of the applicable invoicing date(s). If Customer fails to do so, its payment deadline shall be measured from the invoice date. Effectiveness of this Order Form is not contingent upon receipt of a purchase order. Any terms and conditions set forth in a purchase order inconsistent with those herein or in the Applicable Agreement shall be null and void.
6. Taxes: The prices quoted in this Order Form do not include taxes. As a result, amounts invoiced to Customer may be higher than those stated on this Order.
