

RESOLUTION NO. 26-135

A RESOLUTION OF THE CANYON COUNTY BOARD OF COUNTY COMMISSIONERS CLASSIFYING RECORDS OF THE CANYON COUNTY CLERK AND AUTHORIZING THE DESTRUCTION OF CERTAIN RECORDS

The following Resolution was considered and adopted by the Canyon County, Idaho Board of Commissioners on the 25th day of June, 2026.

Upon the motion of Commissioner Van Beek and the second by Commissioner Brooks, the Board resolves as follows:

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-828 grants the Board authority “to do and perform all other acts . . . which may be necessary to the full discharge of the duties of the chief executive authority of the county government”; and

WHEREAS, Idaho Code § 31-871 requires the Board to authorize the destruction of records that are not required to be retained as permanent records and that have met the minimum retention period provided by the County’s record retention schedule and are no longer required by law or for County business; and

WHEREAS, Idaho Code § 31-871 also provides that records not specifically classified as permanent, semi-permanent or temporary may be classified by the Board of County Commissioners; and

WHEREAS, Idaho Code § 34-217 requires minimum retention periods for certain County election records; and

WHEREAS, the County Clerk has proposed for destruction certain County election records that have exceeded their minimum retention as follows:

- May 2024 9 boxes of Voted Ballots (2-year retention)
- May 2024 6 boxes of Absentee Ballots (2-year retention)
- November 2025 1 box of Spoiled Ballots (60-day retention)
- May 2024 4 boxes of Absentee Affidavit Envelopes (2-year retention)
- May 2024 1 box of Absentee Request Forms (2-year retention)
- May 2020 1 box of Petitions (5-year retention)

WHEREAS, the Prosecuting Attorney has reviewed the proposed destruction of certain County election records, as provided by Idaho Code § 31-871.

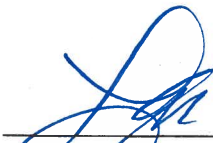
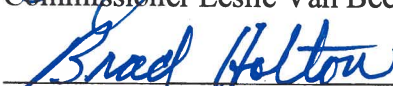

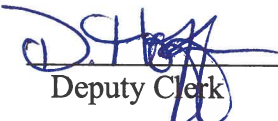
IT IS FURTHER ORDERED that this Resolution shall be effective this 25th day of June, 2026.
