

RESOLUTION NO. 26-136

**A RESOLUTION OF THE CANYON COUNTY BOARD OF COUNTY
COMMISSIONERS APPROVING AWARD OF OFFICER'S BADGE AND DUTY
WEAPON PURSUANT TO IDAHO CODE § 31-830
TO: DETECTIVE MIKE BRYANT**

The following resolution and order was considered and adopted by the Canyon County, Idaho Board of Commissioners ("Board") on this 30th day of June, 2026.

Upon the motion of Commissioner Van Beek and the second by Commissioner Brooks, the Board resolves as follows:

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-828 grants the Board authority "to do and perform all other acts . . . which may be necessary to the full discharge of the duties of the chief executive authority of the county government"; and

WHEREAS, Idaho Code § 31-807 authorizes the Board to manage county property subject to restrictions including, but not limited to, those described in Idaho Code § 31-808; and

WHEREAS, Idaho Code § 31-830 allows for the Board, upon recommendation of the county sheriff, as shown in the attached Exhibit A, to award the handgun and sheriff's badge to a deputy county sheriff holding police officer status under the public employee retirement system of Idaho.

NOW THEREFORE, THE BOARD HEREBY RESOLVES, that Detective Mike Bryant be awarded his duty handgun and deputy county sheriff badge upon his retirement from the Canyon County Sheriff's Office.

IT IS FURTHER RESOLVED BY THE BOARD, that this resolution shall be effective this 30th day of June, 2026.
