

RESOLUTION NO. 26-138

A RESOLUTION OF THE CANYON COUNTY BOARD OF COUNTY COMMISSIONERS ADOPTING UPDATED FEES FOR THE CANYON COUNTY FAIR

The following resolution and order was considered and adopted by the Canyon County, Idaho Board of Commissioners ("Board") on this 30th day of June, 2026.

Upon the motion of Commissioner Van Beek and the second by Commissioner Brooks, the Board resolves as follows:

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-828 grants the Board authority "to do and perform all other acts . . . which may be necessary to the full discharge of the duties of the chief executive authority of the county government"; and

WHEREAS, Idaho Code § 31-807 authorizes the Board to manage county property subject to restrictions including, but not limited to, those described in Idaho Code § 31-808; and

WHEREAS, Idaho Code § 63-1311A requires that public notice of an intent to make a decision on a proposed new fee prior to such decision, be given and a time provided to hear public comment on proposed increase; and

WHEREAS, on June 7, 2022, the Board adopted Canyon County Fair fees and policies associated with the Canyon County Fair's gate admission and livestock entry under Resolution 22-138, which was amended on July 21, 2022, under Resolution No. 22-157; and

WHEREAS, on June 13, 2023, the Board adopted the current fees for the Canyon County Fair under Resolution No. 23-158; and

WHEREAS, the Canyon County Fair Director requests that the fees be updated for the 2026 Fair as outlined in the attached Exhibit A; and

WHEREAS, the Canyon County Fair Director requests that the fees be updated for future fairs, after the 2026 Canyon County Fair, as outlined in the attached Exhibit B until otherwise approved and adopted by this Board; and

WHEREAS, the Board held a public hearing on July 7, 2026, to allow time for public comment regarding the proposed fees outlined in Exhibits A and B in accordance with Idaho Code § 63-1311A.

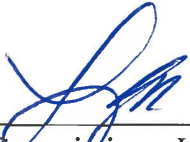
