LEGAL NOTICE IS HEREBY GIVEN that the Board of Canyon County Commissioners will hold a Public Hearing pursuant to Idaho Code § 63-1311A on September 1, 2026, at 9:30 a.m. to consider increasing tipping fees for the Pickles Butte Sanitary Landfill as outlined in "Attachment 1."

This Public Hearing is scheduled for the purpose of hearing public comments regarding the increase of tipping fees and to explain the reasons for such proposed increases. Following the taking of public comments thereon and upon consideration thereof, the Board may make a final decision regarding adoption of the proposed fee increase and resolution. The public hearing will be held in the County Commissioners' Meeting Room, which is located on the First Floor of the Canyon County Courthouse, 1115 Albany Street, Caldwell, Idaho.

Any related documents may be reviewed at the office of the Canyon County Board of Commissioners. Office hours are from 8:00 a.m. to 5:00 p.m., Monday through Friday, except holidays.
